

This led to special studies sponsored by the American Institute of Architects and the Engineers Joint Counsel. The outcome was twofold: the development of a policy of professional liability insurance to insure Engineers and Architects against errors and omissions in the performance of their professional services and the review and development of the customary contractual arrangements defining the design professional's undertakings vis-à-vis his client, the Owner, the Project to be designed, and the Contractor who was to implement that design.
