The medical profession, for example, sets rigorous standards for medical education and licensing to ensure that only qualified individuals can practice medicine. Similarly, the legal profession maintains strict codes of conduct and disciplinary procedures to deal with instances of professional misconduct, thus maintaining the integrity of the legal system. However, this autonomy is not absolute; it's a negotiated balance constantly refined by societal expectations and legal frameworks. The degree of autonomy varies from profession to profession and is often challenged by external forces such as government regulation or technological advances. The concept of self-regulation is inextricably linked to the ethical responsibilities inherent in professional practice.
