Section 170.9

§ 170.9. Acceptance of gifts; value limit; exceptions; adjustments; travel expenses

(a) A judge shall not accept gifts from a single source in a calendar year with a total value of more than two hundred fifty dollars (\$250). This section shall not be construed to authorize the receipt of gifts that would otherwise be prohibited by the Code of Judicial Ethics adopted by the California Supreme Court or any other law.

(b) This section shall not prohibit or limit the following:

- (1) Payments, advances, or reimbursements for travel and related lodging and subsistence permitted by subdivision (a).
- (2) Wedding gifts and gifts exchanged between individuals on birthdays, holidays and other similar occasions, if the gifts exchanged are not substantially disproportionate in value.
- (3) A gift, request, favor, or loan from a person whose preexisting relationship with a judge would prevent the judge from hearing a case involving that person, under the Code of Judicial Ethics adopted by the California Supreme Court.

(c) For purposes of this section, "judge" includes all of the following:

- (1) Judges of the superior courts.
- (2) Justices of the courts of appeal and the Supreme Court.
- (3) Subordinate judicial officers, as defined in Section 21001 of the Government Code.

(d) The gift limitation amount in this section shall be adjusted annually by the Commission on Judicial Performance to reflect changes in the Consumer Price Index, rounded to the nearest ten dollars (\$10).
