Article I
Section 1
All legislative Powers herein granted shall be vested in a Congress of the United States, which shall consist of a Senate and House of Representatives.
Section 2
The House of Representatives shall be composed of Members chosen every second Year by the People of the several States, and the Electors in each State shall have the Qualifications requisite for Electors of the most numerous Branch of the State Legislature.
Section 3
The Senate of the United States shall be composed of two Senators from each State, chosen by the Legislature thereof, for six Years; and each Senator shall have the Qualifications requisite for Senators of the most numerous Branch of the State Legislature.
Section 4
The Times, Places and Manner of holding the Elections of Senators and Representatives, shall be prescribed in each State by the Legislature thereof; but the Congress may at any time by Law alter or change in any or all these Particulars.
Section 5
The Congress shall determine the Rules of the Proceedings of the Senate and House of Representatives, and may punish for Contempt either of them any Member thereof, and may expel a Member of either of them for Misbehavior.
Section 6
The Senators and Representatives shall receive a Compensation for their Services, which shall be ascertained from Time to Time by the Congress.
Section 7
All Bills for raising Revenue shall originate in the House of Representatives; but the Senate may propose or concur with Amendments as on other Bills.
Section 8
The Congress shall have Power to lay and collect Taxes, Duties, Imposts and Excises, to pay the Debts and provide for the common Defence and general Welfare of the United States; but all Duties, Imposts and Excises shall be uniform throughout the United States.
Section 9
The Congress shall have Power to regulate Commerce with foreign Nations, among the several States, and with the Indian Tribes.
Section 10
No State shall enter into any Treaty, Alliance or Confederation; grant Letters of Marque and Reprisal; coin Money; emit Bills of Credit; enter into any Compact or Agreement with another State, or with a foreign Power, or with the Indians; or grant any Title of Nobility.
Section 11
The Congress shall have Power to punish Counterfeiting of the Securities and current Coin of the United States.
Section 12
The Congress shall have Power to declare and coin Money.
Section 13
The Congress shall have Power to fix the Standard of Weights and Measures.
Section 14
The Congress shall have Power to declare Bankruptcies.
Section 15
The Congress shall have Power to suspend the Habeas Corpus, when necessary, but not so as to affect the right of any Person to be heard by the Courts of Law.
Section 16
The Congress shall have Power to dispose of and make all needful Rules and Regulations respecting the Territory or other Property belonging to the United States; and nothing herein contained shall be construed to deny or disparage the Claims of the United States to any Territory or other Property.
Section 17
The Congress shall have Power to constitute Tribunals inferior to the Supreme Court.
Section 18
The Congress shall have Power to make all Laws which shall be necessary and proper for carrying into Execution the foregoing Powers, and all other Powers vested by this Constitution in the Government of the United States, or in any of its Departments or Officers.
